The Department has received your request "for information pursuant to the Public Records Act regarding state evaluators under contract to this agency to perform SVPA evaluations." You asked for a breakdown by "race of evaluator", "age of evaluator", gender of evaluator", "license type held by evaluator", and "special qualifications of evaluator noted by DMH" for the period from "1996 to date."

The Department has determined, however, that it does not possess any records that contain all the information that you have requested. However, the Department has a summary of the contracted evaluators' license type, i.e. PhD, Psy.D. This attached summary is based upon the current contract from July 1, 2009 to December 31, 2011. These contracts were in response to the State's bidding process (IFB no. 09-79029-000) which required Bidder Minimum Qualifications. A copy of these license requirements is also attached.

The contracts prior to July 1, 2009 were not pursuant to the bidding process, so there is no corresponding IFB. Also, there is no existing summary similar to the above for these prior contracts.

Possession of a valid license as a Psychologist issued by the California Board of Psychology and possession of an earned Doctorate Degree in Psychology from an educational institution meeting the criteria of Section 2914 of the Medical Board of California's Business and Professions Code.

Five years of full-time postdoctoral, post-internship experience in the practice of psychological evaluation and risk assessment and diagnosis of high risk sex offenders and/or sexually violent predators (for cases requiring difference of opinion evaluations) or

Three years of full-time postdoctoral, post-internship experience in the practice of psychological evaluation and risk assessment and diagnosis of high risk sex offenders and/or sexually violent predators.

Five years as a licensed psychologist.

Eight (8) hours of expert witness testimony in sexually violent predator cases. Verification of testimony hours must be indicated in Attachment 11.
