SUBJECT: Response to court order by the Honorable Robert A. Barclay,

The current report is written in response to the Court Order by the Honorable Robert A. Biarday to provide information to Defense Attorney, Jim McEntee.

The court had ordered that recidivism information be provided for all individuals released from the Atascadero State Hospital without having completed sex offender specific treatment. The total was calculated at 118, a number that does not include three who have died since release. Unfortunately, the dates of death were not available; one was arrested approximately one month after release from ASH in 2001 and died soon afterward. The other two were noted to have died but no dates were provided.

Review of all data showed that information for 25 of the 119 was not reliable [for example, the Vicient Crime Information Network (Megan's Law web site) showed that some individuals were incarcerated but the CII showed no such information]. Given the time constraints of the request, I am able to reliably report on 93 Individuals from our sample. The follow-up period is just over 6 years and time at risk is calculated at 4.71 years.

The section below includes all sex offens is (six or about 6%). As noted, four (4%) of these offenses were convictions for rape and calld molest (no specific date of arrest or conviction given for number 1 below). One was charged but the outcome is not known (number 3 below) and one was convicted of indecent exposure on numerous occasions (number 6 below).

The next section shows all of the non-sex offenses committed by the cohort. As noted, the rnajority of the offenses were for fallure to register as a sex offender or drug charges. Some offenses were only specified as "Parole Violations" and no specific information was given. Many of the offenses were misdemeanors.

Of the five individuals released from ASH who have completed sex offender specific treatment, none have recidivated and all are appropriately registered. None have died. One individual was returned to ASH for violating the conditions of his release by allowing himself to be in the presence of children.
